Sir/Madam,

I am directed to refer to MCI's letter No. MCI-37(1)(RI-70)/2016-Med./147915 dated 25.11.2016 on the subject mentioned above and to convey the approval of the Central Government for renewal of permission for admission of 3rd Batch of MBBS students against increased intake i.e. from 150-200 for the academic year 2017-18 at Kamineni Institute of Medical Sciences, Nalgonda under Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

2. The permission is valid for one year and for admitting only one batch of students against increased intake i.e. 150-200 during the academic session 2017-18. The next batch of students against increased intake in MBBS course will be admitted in the college only after permission of Central Government for renewal/recognition.
3. The Government Medical College (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
4. Admissions made in violation of the above conditions will be treated as irregular and action will be initiated under IMC Act & Regulations made thereunder.
5. Discrepancies, if any, may be immediately brought to the notice of MCI and the Central/State Government.
