I am to state that the General Body of this council at its meeting held on 13.11.2008 considered the Council inspector's report (July, 2008) on the standard of examination and other teaching facilities available at Kamineni Institute of Medical Sciences, Narkatpally for purpose of recognition DVD qualification granted by Dr. NTR University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee:-

"The Postgraduate Committee considered the Council Inspector's Report (July, 2008) and noted that Dr. M.Arun Kumar Asstt. Act, 1956 restricting the number of admission to 1 (One) student per year".
