I am to state that the General Body of this council at its meeting held on 01.03.2009 considered the compliance verification report (December, 2008) togetherwith the compliance and the Council inspector's report (July, 2008) on the standard of examination and other teaching facilities available at Kamineni Institute of Medical Sciences, Narkatpally for purpose of approval of MD (General Medicine) qualification granted by Dr. NTR University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee as under:-

"The Postgraduate Committee considered the compliance verification inspection report (Dec.,08) together with compliance and the Council inspector's report (July, 2008) and noted that Dr. Sagar C. Bhuyar, Asstt. Prof., does not possess recognized postgraduate qualification. However, the teaching faculty complement other than the teacher mentioned above is adequate and complete and hence decided to recommend that Kamineni Institute of Medical Sciences, Narkatpally be approved for the award of M.D.(General Medicine) qualification granted by Dr. NTR University of Health Sciences, Vijayawada restricting the number of admissions to 4 (Four) students per year."

You are therefore requested to notify the above qualification at the earliest.
