Sub: Dr. NTR. University of Health Sciences, Vijayawada - Renewal of recognition of MS(Orthopaedics) & D.Ortho. Qualifications in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally.

Sir,

I am directed to state that the Board of Governors, Medical Council of India at its meeting held on 22.08.2013 considered the assessment report (May, 2013) on the standard of examination and other teaching facilities available at Kamineni Institute of Medical Sciences, Narketpally for Renewal of recognition of MS(Orthopaedics) & D.Ortho. Qualifications granted by the Dr. NTR. University of Health Sciences, Vijayawada and it was decided as under:-

"The Board of Governors considered the assessment report (May, 2013) and noted that MS(Ortho.) & D.Ortho. qualifications are already recognised with 03 seats & 02 seats respectively and decided to recommend that MS(Orthopaedics) & D.Ortho. Qualifications granted by Dr. NTR. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally be renewed and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to degree for 03(Three) & diploma for 02(Two) student(s) per year."

The attention of the institute is drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.
