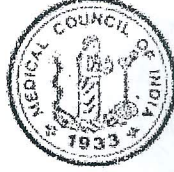

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 28/03/2014 considered Council assessor report (May, 2013) on the physical and other teaching facilities available at Kamineni Institute of Medical Sciences, Narketpally for Renewal of recognition of MD(Pathology) qualification under Dr. NTR. University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (May, 2013) and decided to recommend that MD(Pathology) qualification for 2(Two) seats granted by Dr. NTR. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

Note: The college authorities are directed to get the recognition of 2 PG diploma which were permitted in the year 2005-06.

The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition"

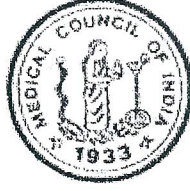


