Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 01/10/2015 considered the Council Assessor's Report (May, 2013) on the physical and other teaching facilities available at Kamineni Institute of Medical Sciences, Narketpally for Renewal of recognition of MS(General Surgery) qualification for 04 seats under Dr. NTR. University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2013) along with compliance dated 27/04/2015 submitted by the College Authorities and decided to recommend that recognition of MS (General Surgery) qualification for 04 seats granted by Dr. N.T.R. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
