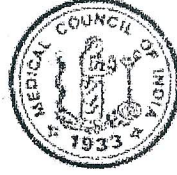

I am to state that the General Body of this Council at its meeting held on 28/03/2014 considered Council assessor report (May, 2013) on the physical and other teaching facilities available at Kamineni Institute of Medical Sciences, Narketpally for Renewal of recognition of MD/MS(OBG) & DGO qualifications under Dr. NTR. University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

“The Postgraduate Committee considered the assessment report (May, 2013) and decided to recommend to renew the recognition of MD/MS(OBG) & DGO qualifications for 3(Three) Degree & 2(Two) Diploma seats granted by Dr. NTR. The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition.”

A copy of assessment report is enclosed herewith.

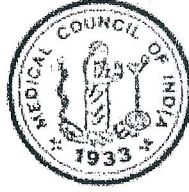
