Sub: Dr. NTR. University of Health Sciences, Vijayawada - Renewal of recognition of MD(Psychiatry) and DPM qualifications in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 26-27/03/2015 considered Council assessor report (May, 2014) on the physical and other teaching facilities available at Kamineni Institute of Medical Sciences, Narketpally for Renewal of recognition of MD(Psychiatry) and DPM qualifications under Dr. NTR. University of Health Sciences, Vijayawada and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

“The Postgraduate Medical Education Committee considered the Assessment Report (May, 2014) and decided to recommend that recognitions of MD(Psychiatry) and DPM qualifications granted by Dr. NTR. University of Health Sciences, Vijayawada in respect of students being trained at Kamineni Institute of Medical Sciences, Narketpally be renewed for 1(One) seats for each course.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.”
